

AGREEMENT FOR DUSK TO DAWN OUTDOOR LIGHTING COMPANY-OWNED LAMP FIXTURE

The undersigned member (hereinafter called the Applicant) hereby agrees to purchase dusk-to-dawn outdoor lighting service from Citizens Electric Corporation (hereinafter called the Corporation), and the Corporation agrees to furnish said service for the following purpose and upon the following terms and conditions:

- Dusk-to-Dawn Lighting
- Street Lighting (municipalities, homeowner associations, etc.)

1. The Applicant requests the following dusk-to-dawn outdoor light fixture(s) be installed by the Corporation at a place to be agreed upon by the Applicant and Corporation:

2. It is understood and agreed by and between parties that service can or will be made available only on an existing pole and where the Corporation has secondary service available, with the following exceptions:
- (a) The Corporation will extend its secondary conductor one span not to exceed 175 feet in length and install one wood pole including guy and anchor where needed for an additional one time charge of \$300.00.
 - (b) The Corporation will install secondary conductor only (6/2 duplex) not to exceed one normal span to permit installation of an LED fixture when such installation is requested by the Applicant and when installation is considered practical by the District Superintendent. An additional one-time charge of \$100.00 shall be paid by the Applicant.
 - (c) The Corporation will set a transformer (not to exceed 5 kVa capacity) to energize the LED fixture. The additional monthly charge for the transformer is set forth in rates approved by the Board of Directors.
3. The Corporation agrees to furnish the lamp fixture, electrical energy for the operation of lamp, and maintenance of the lamp fixture to render adequate service. Required maintenance will occur within a reasonable length of time after notification by the Applicant.
4. It is understood that title and ownership of all equipment shall remain in the Corporation and that no connection to, or extensions of, the circuit serving the unmetered lamp or lamps may be made by or on behalf of the Applicant.
5. The Applicant agrees to pay for this service at the Corporation's current rate for Outdoor Lighting Service as approved by the Board of Directors from time to time. It is further agreed that the Corporation may remove the equipment installed pursuant to this Agreement for reason of excessive or malicious damage to the equipment or failure of the Applicant to pay for said service by due date.
6. If Applicant desires to increase the quantity of dusk-to-dawn outdoor light fixtures used for **STREET LIGHT purposes only**, Applicant shall request same in writing addressed to Citizens Electric Corporation, c/o Member Services Dept., P.O. Box 368, Perryville, Missouri 63775.
7. This Agreement shall be binding upon both parties, their successors or assigns, for a period of twelve (12) months from the date of acceptance and shall continue thereafter until cancelled by either party.
